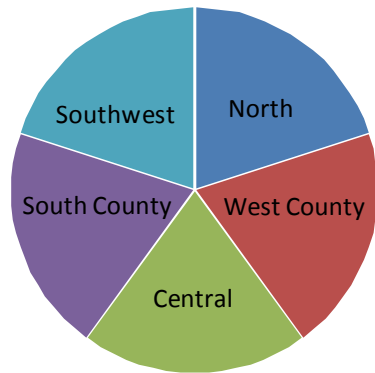


GSLDS Member Districts are based on their:

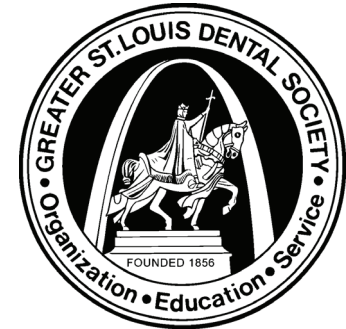
