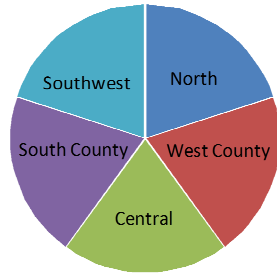


GSLDS Members' Districts are based on their office location
