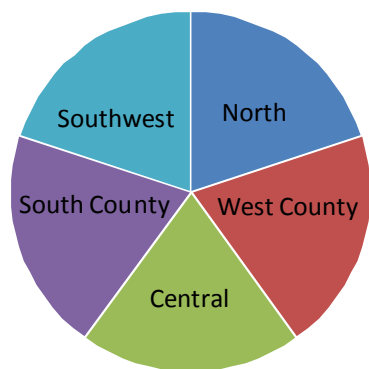


**GSLDS Member Districts are based on their:**
